## Collective bargaining and goals of the past:

- 16.4% in pay behind private sector in the past
- Fair treatment in workplace
- Improve benefits
- Fill vacancies
- Received the 3% pay increase for 3 years in a row
- State will now have a \$15/hr minimum wage
- Locked in healthcare for the next 3 years
- Annual leave accruals

## **Upcoming:**

- Starting July 1 Paid family medical leave = 160 hrs every 12 months
- On call pay
- EDI committee established
- Pay study is coming
  - o RFP posted 4/19/22 looking for vendors to do the study
  - Will compare all jobs with jobs in the private sector and report back what pay equities should be
  - o From there, negotiations will reopen
  - o Possible STEP increases for those working with the state for so long
  - Pay Equity Study RFP AABA 2022\*0364 was posted to Colorado VSS on Tuesday April 19, 2022; Proposals are due on Thursday May 12, 2022. Here are instructions to view the RFP on Colorado VSS:
    - 1. Go to colorado.gov/vss

- 2. On the left side of the page, click a button that says "Public Access."
- 3. In the Keyword search, type "Pay Equity Study" and press ENTER. Our RFP should be the only one to appear in the search.
- 4. Click on the button that says "Details."
- 5. There is a tab that says "Attachments." Click on that tab. It will bring you to a section that shows all six attachments associated with the RFP.
- 6. Download the attachments. Similarly to the "Attachments" tab there is an "Events" Tab which shows all deadlines for potential Offerors. I mention this because written Offeror Inquiries are due to us Monday April 25, 2022, at 12:00pm Mountain Time, as adjusted for Daylight Savings.

**Fun Facts:** Union members earn better wages and benefits than workers who aren't union members. On average, union workers' wages are 11.2% higher than their nonunion counterparts. Ninety-six percent of union workers have employer-provided health insurance, but only 69% of nonunion workers do. Unions help bring more working people into the middle class. In fact, in states where people don't have union rights, workers' incomes are lower.
